The Mashantucket Pequot Tribal Nation shall be known as MPTN.
The Power Scooter/Mobility Device shall be known as Scooter.

Scooter Rental Agreement

Scooter A Long, LLC rents to the Renter signing this Agreement a Scooter subject to all the terms and conditions set forth in this Agreement and Renter agrees.

The Scooter is the property of Scooter A Long, LLC and is in good condition. Renter will return the Scooter in the same condition as when received, at the end of the rental period for inspection and recharge of battery (if necessary), or sooner, upon the demand by Scooter A Long, LLC. Scooter A Long, LLC may repossess the Scooter without demand at any time if it is used in violation of the terms of this Agreement.

Renter may cancel this order at least 24 hours prior to delivery at no cost to the Renter. In the event Renter cancels with less than 24 hours; Renter will be charged a cancellation fee of 100% of the rental fee per Scooter.

Scooter A Long, LLC, MPGE & MPTN shall not be liable or responsible for the loss of or damage to any property left, lost, damaged, stolen, stored or transported by Renter, its agents, servants, or employees, or any other person on the Scooter, either before or after the return thereof to Scooter A Long, LLC. Renter assumes all risk of such loss or damage and waives all claims against Scooter A Long, LLC, MPGE & MPTN by reason thereof and Renter agrees to hold Scooter A Long, LLC, MPGE & MPTN harmless against all claims based upon or arising out of such loss or damage.

Renter is responsible for the Scooter and its operation; if Loss and Damage Insurance is purchased at the time of Rental Agreement, then Renter will be covered to its limits. If insurance is not purchased, or the insurance does not provide coverage, and damages of any kind occur then the Renter will reimburse Scooter A Long, LLC for any damages including loss, theft or destruction of the Scooter.

Renter assumes all risk and liability for any loss, damage or injury, including death, to persons or property of Renter or others arising out of the use, operation or driving of the Scooter.

Any damage to the scooter will be evaluated with an estimate and a call to the customer to reimburse Scooter A. Long in full plus labor. (initial) _____

Any loss or theft of keys will result in a \$15 charge. (initial) _____

Renter shall defend, indemnify and hold harmless the MPGE, MPTN and Scooter A Long, LLC all their agents, officers, servants and employees from and against any and all losses, liability claims, damages, injuries, demands, actions and causes of the action whatsoever, including legal fees and distributions arising out of or related to any loss, damages or injury claimed by persons that may arise from the use operation or driving of the Scooter, provided that such loss or damage was not caused by the fault or gross negligence and willful misconduct of Scooter A Long, LLC.

Renter understands and authorizes that Scooter A Long, LLC will charge the credit card used for any repair costs or the replacement costs of the Scooter.

The following restrictions are cumulative and each shall apply to every use, operation or driving of the Scooter.

Under no circumstances shall the Scooter be used, operated by any person a) under the age of 18; or b) while under the influence of alcohol, intoxicants or narcotics; or c) in an unsafe manner; No one other than Renter may drive the Scooter; No passengers are allowed on the Scooter; Renter will give all pedestrians the right of way; The scooter is not to leave the inside of Foxwoods Casino, No outdoor use; Renter will not use the Scooter on stairs, escalators or moving sidewalks; Renter will operate at a safe speed; and Renter will cease operation of the Scooter and inform Scooter A Long, LLC of any defects noticeable on the Scooter.

Renter assumes all costs and expenses of every kind and nature including legal fees and disbursements arising out of and in connection with the use, operation or driving of the Scooter.

MPGE, MPTN and Scooter A Long, LLC assumes no liability or responsibility for any acts or omissions of Renter or of Renter's agents, servants or employees.

Renter shall operate the Scooter with reasonable care and diligence and to comply with the terms of this Agreement. Renter shall notify Scooter A Long, LLC immediately of any and all accidents and damages.

Renter agrees to pay all costs, expenses and attorneys fees incurred by Scooter A Long, LLC, MPGE and MPTN in collecting sums due or in regaining possession of Scooter or in enforcing or recovering any damage, losses or claims against Renter.

Renter shall in no event be deemed the agent or employee of Scooter A Long, LLC in any manner or for any purpose whatsoever.

Any individual executing this Agreement as Renter in a representative capacity shall be bound personally, jointly and severally, with such fiduciary, corporation or other entity as to all obligations, expressed or implied, arising hereunder.

If any provision hereof or the application of any provisions to any person or circumstance is held invalid or unenforceable, the remainder hereof and the application of such provision to other persons or circumstances shall remain valid and enforceable.

NO SHOW/CANCELLATION Policy

As a courtesy to fellow customers kindly cancel any unneeded reservation as soon as your plans change.

In **ALL** cases, a cancellation fee of 100% of the rental fee shall be applied if an unwanted reservation is not cancelled at least 24 hours prior to scheduled delivery time and 100% if the customer fails to pick up the Scooter within three hours of the scheduled pickup time.

Scooter A Long, LLC reserved the right to rent the Scooter if such equipment has not been picked up within three hours of the scheduled time.

It is the sole responsibility of said Renter to communicate with Scooter A Long, LLC to ensure that the Scooter is available to avoid additional cancellation fees/charges.

If said Renter orders for more than one day and returns the Scooter early, there will be no refund as the Scooter has been put on hold for the day requested.

Rental Extensions

Scooter A Long, LLC is in the business of hospitality. Scheduling is imperative to ensure that all of our guests' requests are met. Scooter is due back at the date and time and location specified on the Rental Agreement. If you need to extend your rental, you must call Scooter A Long, LLC prior to the expiration of the Rental Agreement. All effort shall be made to provide you with an extension of your Rental Agreement. In certain situations, based on availability, the rental extension request may be denied.

Out of Battery

Scooter which requires an electrical charge is full charged by Scooter A Long, LLC when rented to the renter. It is the Renter's responsibility to charge the battery as needed. If you forget to charge the battery and become stranded, you may call Scooter A Long and request a service call for Battery Charge. This service is at a rate of \$15.00 during normal business hours. If a tech has to be called in for this service a charge of \$35.00 will be applied to your Rental Agreement.
